Session Objectives

During this session, GAC members will have the opportunity to discuss the proposed PIR acquisition among themselves, share individual viewpoints, react to information shared during the ICANN67 Public Forum 1 held earlier in the day and discuss any further GAC follow-up actions.

Background

On 13 November 2019, the Internet Society (ISOC) and the .org registry domain operator Public Interest Registry (PIR) announced the acquisition of PIR from ISOC by Ethos Capital. Although all the details of the agreement were not initially explained, it was represented that Ethos Capital would acquire PIR and all of its assets from the ISOC and the transaction was expected to close during the first quarter of 2020.

On 14 November 2019, PIR submitted a formal Application for Indirect Change of Control to ICANN (see - https://www.icann.org/en/system/files/correspondence/cimbolic-to-icann-14nov19-en.pdf).

On 9 December 2019, ICANN org made a request to PIR for additional information (see https://www.icann.org/en/system/files/files/pir-isoc-ethos-capital-10jan20-en.pdf - at Section 2).

On 9 December, the ICANN CEO published a blog post providing an update on the matter and announcing the request for additional information (see - ".ORG Update" - https://www.icann.org/news/blog/org-update

On 20 December 2019, PIR submitted "confidential responses" to the 9 December ICANN org request for additional information. A revised/redacted version of those responses was announced

Interest by Other Parties

Other organizations

Shortly after the transaction was announced and during the following months, a number of different organizations and individuals communicated their opinions of the proposed acquisition to ICANN. In addition to a letter from the GAC, those parties included the Electronic Frontier Foundation (EFF), the Internet Commerce Association, the Mozilla Foundation, the ICANN Non Commercial Stakeholder Group (NCSG) and others. On 21 February, the EFF and the Americans for Financial Reform Education Fund asked the U.S. Federal Trade Commission to closely scrutinize the proposed transaction (see -

U.S. Congress

On 23 December, several members of the U.S. Congress sought information about the proposed transaction from ISOC and raised questions over potential harms that the sale of .org could have on nonprofit groups, free speech, and Internet users. ISOC, PIR, and Ethos replied to those questions on 6 January 2020 (see

California Attorney General

On 23 January, the Office of the Attorney General of the State of California (CA-AGO) requested information from ICANN regarding the proposed transaction in order to "analyze the impact to the nonprofit community, including to ICANN." ICANN announced receipt of that request in a blog post on 30 January (see - https://www.icann.org/news/announcement-2020-01-30-en). Subsequently the organization corresponded with the CA-AGO and followed up with PIR and ISOC for additional information to address questions presented by the CA-AGO.

Extensions of time

Section 7.5 of the .org registry agreement (and each of the other registry agreements between PIR and ICANN) contemplates that ICANN will respond to requests such as the PIR Application for Indirect Change of Control within 30 days of receiving the request. So far, ICANN and PIR have agreed to a number of extensions of that calendar time period to exchange further information

about the transaction. Links to that correspondence can be found in the "Further Information" section of this briefing.

GAC Positions

The November PIR/ISOC/Ethos announcement prompted substantial community interest, and GAC members returned from the IGF Berlin meeting (25-29 November) reporting that the announcement was a hot-topic at that event.

Subsequently, the GAC leadership discussed the potential for production of a GAC reaction to the announcement proposing that a possible GAC communication regarding the topic to ICANN could reference "concerns of the community", request "fact-based information from ICANN's point of view" (delegation of the registry) and ask ICANN what steps (if any) were being taken by ICANN to safeguard the global public interest

A communication expressing those points generally was sent by the GAC Chair to the ICANN Board Chair and CEO on 7 January 2020. In that letter, the GAC stated, <u>inter alia</u>:

"Specifically, the GAC wishes to underscore its interest in being kept informed about what steps are being, will be or could be considered by ICANN org to safeguard the global public interest regarding the PIR transaction.

The GAC would also be interested in what process or mechanism exists or could be established to allow any concerned members of the ICANN community to appropriately express their views regarding the transaction."

On 7 February, the GAC representative from France transmitted a letter to the ICANN CEO asking him to:

- 1. Send us your detailed opinion on the proposed transaction and any alternatives that may be considered, and
- 2. Give the GAC the opportunity, before giving your approval, to study the sale more precisely and to make potential recommendations, particularly during ICANN67.

On 14 February, the ICANN Board Chair responded to the GAC Chair letter of 7 January, noting several recent ICANN Announcements regarding the PIR transaction to date and also stating:

"Your letter conveys the GAC's interest in a process or mechanism that allows the ICANN community to express their views or concerns about the transaction. The ICANN Board and ICANN org appreciate the correspondence received to date and are grateful for the community input. We encourage those interested to also communicate their views or questions about the registry operations and/or policies directly to ISOC, PIR, and/or Ethos Capital.

In parallel with the California Attorney General's inquiry (referenced above), ICANN will

continue to conduct thorough due diligence in its consideration of the proposed change of control and provide relevant updates to the community. Thank you for the GAC's interest in this topic."

ICANN67 Agenda

During ICANN67, the Public Forum 1 on Monday 9 March will focus on community input regarding the proposed PIR transaction with the entire 90-minute session devoted to that topic.

The GAC plenary session #3, also on Monday, will enable GAC Members to discuss the topic among themselves, share individual viewpoints, react to information shared during the Public Forum 1 and discuss any further necessary GAC actions.
