Session Objectives

An ICANN Public Meeting creates the opportunity for the GAC to meet and interact with other ICANN groups, organizations and structures - enabling the committee to coordinate and resolve specific policy work and operational matters and to build channels of communication with other groups to address current issues of government interest and facilitate future informational exchanges. The GAC Meeting with the ICANN Board of Directors is one of those important opportunities. The Tuesday, 24 October GAC meeting with the ICANN Board at ICANN78 will enable the GAC to share views and ask timely questions of Board Members on topics of importance to the committee.

Recent Developments

Recent GAC-Board Meetings have covered a range of subjects and topics that have mostly centered around formal questions the GAC submits to the Board about two to three weeks before the start of the ICANN Public Meeting. For some meetings, the Board presents a number of standard questions or session topics to community groups for them to respond to the Board.

For ICANN78, the Board has proposed several optional questions from which the GAC is encouraged to choose. Those questions include:

- 1. What are the GAC priority topics/issues for the coming calendar year?
- 2. What significant Internet developments are GAC Member governments paying attention to this year and next year?
- 3. Has the GAC considered further follow-up on the Topic 30 GAC Early Warnings language discussed with the Board during the recent Communiqué Clarifying call?
- 4. What are the other current key areas of GAC focus regarding the next round of new qTLDs?

5. Do GAC members have any suggestions for improving the tracking and reporting tools for GAC advice and Issues of Importance?

Preliminary feedback from GAC participants on the committee email list reveal inclinations to focus on Questions 2 and 3 proposed by the Board.

With respect to the topics and questions from the GAC to the ICANN Board, during the ICANN78 Agenda Setting Call on 14 September 2023, GAC members agreed that the committee should limit the list of topics to discuss with the Board to allow more time for focused dialogue on government priorities. The two primary topics of the Next Round of New Generic Top-Level Domains and DNS Abuse were identified for potential questions to ask the Board. Since then a third topic - registration data policy - has also been proposed.

GAC Members will discuss particular drafted questions to present to the Board during a special committee pre-meeting preparatory call on Thursday, 12 October, after which finalized questions will be shared with the Board in preparation for the meeting.
