



# **GAC Meeting with ICANN Board**

**Session 11** 

### **Session Objectives**

An ICANN Public Meeting creates the opportunity for the GAC to meet and interact with other ICANN groups, organizations and structures - enabling the committee to coordinate and resolve specific policy work and operational matters and to build channels of communication with other groups to address current issues of government interest and facilitate future informational exchanges.

The GAC Meeting with the ICANN Board of Directors is one of those traditional opportunities that takes place at every GAC Public Meeting. The Monday, 27 October GAC meeting with the ICANN Board at ICANN84 will enable the GAC to share views and ask timely questions of Board Members on topics of importance to governments in ICANN.

### **Recent Developments**

Recent GAC-Board Meetings have covered a range of subjects and topics that have mostly centered around formal questions the GAC submits to the Board about two to three weeks before the start of the ICANN Public Meeting.

For some meetings, the Board presents a number of standard questions or session topics to community groups for them to respond to the Board. For ICANN84, the Board has shared the following question for the GAC ahead of the meeting:

"What does the GAC believe should be the Board's and the ICANN organization's policy priorities in 2026, taking into consideration the new Five-Year Strategic Plan, the WSIS+20 review, and the recently launched Cross Community Group on the Review of Reviews?"

With respect to the topics and questions from the GAC "to" the ICANN Board, during the ICANN84 Agenda Setting Calls on 22 July and 23 September, GAC members were asked to share potential topics and questions for compilation by GAC Support staff and subsequent curation from the GAC Chair and Vice Chair (C-VC) team.

As of 8 October 2025, support staff was still awaiting topic and question contributions from GAC delegates and topic leads. An initial list of topics for ICANN84 were scheduled to be shared with the Board by 17 October. GAC Members subsequently reviewed and confirmed them (as well as any





associated questions) during a special committee pre-meeting preparatory call scheduled for 20 October. Subsequently, the finalized topics/questions, in slide deck form, have been shared with the Board in preparation for the meeting.
