  - Outcomes evaluated after each event




### **Overview of Program, P2**

    - Africa
      - Nairobi, Kenya; Johannesburg, South Africa and Dakar, Senegal
    - Asia/Pacific
      - Nandi, Fiji; Kathmandu, Nepal
    - Middle East
      - Abu Dhabi, UAE
    - Latin America Caribbean
      - San Juan, Puerto Rico; Panama
  - Around 250 participants from GAC and non GAC member countries
