Suggestions to Improve Communique Structure

- The Board does not recommend making any changes to the current GAC Communique structure, other than the request to ensure that all "asks to the Board" are presented in that section, to avoid all possible misunderstandings;
- Regarding the section "Follow-up on Previous Advice", the Board suggests that these items be tracked via the Action Request Register (ARR) and not via the Communique. Any open advice items will be monitored via the ARR.




Action Request Register - GAC Advice

- ICANN org started using Action Request Register (ARR) to track GAC Advice items in June 2017
 - Reviewed all GAC Communiques starting from ICANN46 (Beijing)
 - Parsed the advice documents to identify each unique actionable item
 - Documented evidence of ICANN Board or org's responses and actions to address the advice
 - GAC Advice inventory presented to GAC at ICANN60 (Abu Dhabi)
- ICANN Board looks forward to feedback from the BGRI on the GAC Advice inventory
 - All items have been considered by the Board
 - 14 items pending ongoing community work (see next slides)
 - 12 items pending ongoing implementation work (see next slides)



GAC Advice Items by ARR Phase



Phase	Definition of Phase	
Phase 1 Receive & Publish	GAC is producing Advice and ICANN Board/organization has not yet received or published	
Phase 2 Understand	ICANN Board/org is reviewing the advice to identify any questions needing clarification before formal Board consideration (new since Copenhagen Communiqué)	
Phase 3 Evaluate & Consider	The ICANN Board is in the process of formally considering the advice via a scorecard and/or resolution. Items may also appear in this phase because further Board consideration may be required. Note: The items currently in this phase have all been considered by the Board; however, they are pending ongoing community action which may require additional consideration by the Board	
Phase 4 Implement	The Board has considered the advice and directed the CEO and ICANN org to proceed with action or implementation. This action or implementation is currently underway.	
Phase 5 Close Request	The ICANN org has reviewed the advice and has determined the advice has been considered, and all directed action or implementation has been completed.

Red Cross/Red Crescent	Ongoing community discussions relating to "Final Report on Protection of IGO and INGO Identifiers in All gTLDs Policy Development Process"
RAM	The Board encourages impacted parties to continue discussions.

Advice Category	Ongoing Implementation Action	
2-Character Country/Territory Codes at the Second Level	The Board has directed the CEO to engage with concerned governments to listen to their views and concerns and further explain the Board's decision-making process.	
Applications for .amazon and related strings	The Board has asked the CEO to facilitate negotiations between the Amazon Cooperation Treaty Organization's (ACTO) member states and the Amazon corporation.	
Enabling inclusive, informed and meaningful participation in ICANN	The Board will continue to encourage the ICANN organization to produce materials for community use that will facilitate broad and meaningful participation from all stakeholders globally and is open to suggestions on further improvement, and will balance this against the availability of resources.	
General Data Protection Regulation (GDPR)/WHOIS	The Board welcomes the GAC's full engagement with the community on the GDPR-related discussions and is committed to continuing to facilitate this discussion in a transparent way.	
ccTLD String Similarity	Board adopted resolution on "Refinement of string similarity review in IDN ccTLD Fast Track Process" at ICANN60 and directed CEO to move forward with implementation.




