#### **ICANN's Mission**

The mission of the Internet Corporation for Assigned Names and Numbers (ICANN) is to ensure the stable and secure operation of the Internet's unique identifier systems

#### Specifically, ICANN:



Coordinates the allocation and assignment of names in the root zone of the Domain Name System



Coordinates the development and implementation of policies concerning the registration of second-level domain names in generic top-level domains (gTLDs)



Facilitates the coordination of the operation and evolution of the DNS root name server system



Coordinates the allocation and assignment at the top-most level of Internet Protocol numbers and Autonomous System numbers



Collaborates with other bodies as appropriate to provide registries needed for the functioning of the Internet as specified by Internet protocol standards development organizations




# **ICANN Ecosystem**



#### How the GAC works

- 3 meetings/year where it discusses issues with the ICANN Board and other ICANN SO/AC and other groups.
- 6 UN languages + Portuguese for meetings.
- Travel support for 40 participants (35 for GAC Members and 5 for Observers) per meeting
- Mailing lists and Conference calls

- ICANN Policy Staff and ICANN GAC Support provide full support to the GAC

## **Active GAC Working Groups on Substance**

- GAC Working Group on Under-Served Regions (USRWG): Focuses on regions under-served by the DNS industry, and least developed economies and small island developing states. A particular focus is on under-served economies/countries from the Africa, Caribbean and Pacific (ACP) regions.
- GAC Working Group to Examine the Protection of Geographic Names in any Future Expansion of gTLDs: Examines the Protection of Geographic Names in any Future Expansion of gTLDs to review and considers any necessary improvements to the existing protections
- GAC Public Safety Working Group (PSWG): Focuses on aspects of ICANN's policies and procedures that implicate the safety of the public
- GAC Working Group on Human Rights and International Law (HRILWG): Focuses on aspects of ICANN's policies and procedures which relate to human rights and relevant international law

# GAC Capacity Building Workshop Initiative



#### **Overview**

 Concept proposed through work plan endorsed by the Governmental Advisory Committee

Rational: to **lower barriers to participation while increasing diversity and effective participation** of GAC members from under-served regions on the functioning of ICANN

- Demand driven capacity building
  - Agendas and locations determined by the GAC
  - Locations chosen to provide diversity of access and leverage existing events
- Pre and post workshop surveys
  - Contents determined by target audience
  - Outcomes evaluated after each event


## Overview of the First Phase of the Program 3/3
