Introduction

- GAC leadership elections process begins here at ICANN65 and concludes at ICANN66 in Montreal (2-7 November 2019)
- Open seats: 5 GAC Vice Chairs
- Two of the current Vice Chairs are eligible for re-election
- Nomination period open from ICANN65 until 18 September
- Nominations as well as self-nominations are possible
- More than five nominations for Vice Chairs will require a voting period
- If voting is needed online tool utilized (Tally)



Nominations

- Nominations should be made by email to gac@icann.org
- Staff will send an email confirmation to the nominator that the nomination has been recorded
- If third party nomination, staff will also verify that the nominee is willing to stand for election
- GAC Web site election page will track all nominations
- When the nomination period has closed, staff will inform the GAC by email about the list of nominees for the open positions – and clarify whether balloting is necessary.





Balloting

- If balloting needed online "Tally" system will be used
- Used by GAC for the 2017 election and GNSO for more than 6 years for elections and voting on documents
- Tally system is based on the electorate being identified by email addresses
- Default assumption that the <u>first named representative</u> (and email address) on the website entry for the GAC Member will be the voting delegate
- Important that all GAC Members check their entries and notify gac-staff@icann.org if another listed individual and/or another email address should be used
- Staff will confirm receipt of such notifications by email



Timelines and Important Dates

- Nomination period ICANN65 (27 June) ending 18 September
- Balloting period if necessary 19 September –
 5 November (ending during ICANN66)
- New Term begins 12 March 2020 (after ICANN67)



GAC Public Comments Assessment Process

- C-VC Leadership advised of Upcoming Public Comments
- Leadership team discusses topic and potential GAC interest
- GAC alerted by email for GAC and individual Member consideration
- If interest drafting conducted
- GAC Web Page developed and updated to record decisions and track process, if necessary





New Membership Management Practices

- Changes in Privacy Culture, need for metrics and strategic planning driving GAC to enterprise membership tool
- Salesforce
- Basic effort now complete
- Features ability to track membership info
- Features ability to "forget" participants but retain aggregate data
- Many opportunities to leverage for reporting and communications management
- Staff to follow-up to build up database pre 2013 records need updating



Attendance at ICANN Meetings

- RSVP process gaining acceptance (began only for ICANN63)
- Useful for planning and preparations
- Helpful for accountability and transparency (e.g., HRIL)
- Potential applicability for Operating Principles
- Intention to professionalize the attendance taking process
- Experimentation with Use of improved technologies (ICANN 64, 65, 66)





Efforts to facilitate Participation in GAC Working Groups

- GAC stabilized at annual ~24-26 % participation change rate
- Opportunities for new participants
- Leadership connection with Working Group leadership
- Leadership encouragement to volunteer
- Guidelines development by GOPE WG impacting Operating Principles
- Improved Working Group record keeping (Salesforce attendance)
- Improved framework will improve efficacy
- Another reminder in about a month





Implementation of New Privacy Policies at ICANN Org

- GAC tradition of confidentiality
- GAC Support staff asked to implement ICANN org policies to protect participant privacy
- Efforts began last year
- Requires staff to ask new participants (members and observer delegates) to provide filled in consent forms
- Forms necessary to complete records updates
- Please complete forms at earliest convenience
