- ICANN69: HRILWG co-chairs agreed to focus on the GAC's implementation of the new ICANN Human Rights Core Value along with the consideration of WS2 diversity recommendations.
- Pre-ICANN70: HRILWG and USRWG collaboration on the definition of diversity from a GAC perspective (preliminary focus on recommendations 1.1 and 1.2)
- WS2 Final Report - Seven key elements of diversity (Rec 1.1):
 - Geographic or Regional Representation
 - Developing and underserved regions
 - Developmental status
 - Language
 - Gender
 - Age
 - Physical Disability
 - Diverse Skills
 - Stakeholder Group or Constituency

- November 2018, the [31st Council Meeting of UNESCO](https://en.unesco.org/internet-universality-indicators/roamx-indicators)'s International Programme for the Development of Communication (IPDC) approved the ROAM indicators: <https://en.unesco.org/internet-universality-indicators/roamx-indicators>.
- The aim is to **assess the state of Internet development at the national level** according to the ROAM principles of human **R**ights, **O**penness, **A**ccessibility, **M**ulti-stakeholder participation.
- The Council “endorsed the use of this tool on a voluntary basis as a useful resource available for Member States”; and “encouraged interested Member States and all stakeholders, on a voluntary basis, to support and conduct national assessments of Internet development with the Internet Universality Indicators”.

They serve to measure not only gender balance, but also all other Human Rights applied to Internet world.
