 - Ola Bergström (Sweden)
 - Muhammed Fatih Kafadar (Turkey)
- Thank you to all the candidates for your willingness to serve
- Quorum requirements of GAC Operating Principle have been met (over 100 ballots submitted and recorded) and Electronic (Tally system) Election/Voting system worked reliably
- No ties that would prohibit identifying the candidates with the five highest vote counts - (paper balloting not needed)
