### ALAC Talking Points

- The GPIF is a pilot which is under consideration as a lense through which the Board and Community could situate recommendations and positions
- It is based on and bounded by ICANN's Articles of Incorporation and By-laws
- End user interests, as they are reflected in these governing documents,
   must be honoured

# **Universal Acceptance and Internationalized Domain Names**

### **ALAC Questions/Talking Points (1/2)**

- 1. There is clear and significant alignment of interests between GAC and ALAC *vis-à-vis* Universal Acceptance and Internationalized Domain Names (IDNs)
- 2. There are numerous benefits of closing the UA gap
- 3. While UA Readiness has been improving steadily, there are still important gaps, and closing them must be a priority for all
- 4. ALAC has been taking up UA-related activities through our Regional At-Large Organizations (RALOs) bringing together end-users and technical resources
- 5. This year, we are taking up an ALAC-level activity, of identifying end-user perspectives on UA for the Hindi language community through a survey

# **Universal Acceptance and Internationalized Domain Names (IDNs)**

### **ALAC Questions/Talking Points (2/2)**

- 6. UA and IDNs go hand-in-hand, and we need to ensure robust policies that will provide safe and consistent end-user experience
- 7. Towards this, ALAC is actively engaged in policy development through the GNSO EPDP on IDNs
- 8. ALAC would be keen to explore collaboration with GAC in the ongoing work of Universal Acceptance and IDNs

# System for Standardized Access Disclosure (SSAD)

### **ALAC Questions/Talking Points**

- Strong correlation between ALAC and GAC positions
- On review of the Operational Design Analysis (ODA)
- The financial analysis is very obfuscating (a great English word meaning obscure, unclear, unintelligible, bewildering!). The bottom line is that the actual cost (excluding services that people will pay for) is not high.
- The SSAD report allowed ICANN to fully subsidize the development costs and part of the operational costs and the ODA team ignored both.
- The SSAD report allowed requesters to provide assurances of how they would use data and why they are requesting it, both potentially useful in approving requests, and the ODA team did not allow for these.
- Even with the above issues corrected, the SSAD will take too long to deploy, will not provide sufficient value, and will not be able to keep up with new regulations, so it should not be built.
