- [GAC Strategic Plan](#) (2024-2028) Strategic Objective 8 - Internet Governance

The GAC will work to ensure that governments, the ICANN Board, ICANN org and ICANN community participants are kept regularly apprised of developments and challenges in the Internet Governance (IG) ecosystem that impact the Internet's unique identifier systems. The GAC may coordinate efforts among Members to make contributions to global IG processes, within the framework of the multi-stakeholder model.

 - Regularly apprise all GAC participants of Internet Governance developments taking place in 2024 and 2025 and relevant to the GAC and ICANN
 - Inform GAC Members of ICANN org efforts to develop and implement communications and engagement strategies designed to address the WSIS+20 Review, GDC and other relevant processes, and communicate opportunities to contribute as individual governments or collectively as a committee
 - Consideration of a GAC small group dedicated to Internet Governance issue

Shaping the Digital Future: WSIS+20 Review and the Future of Internet Governance


- GAC Webinar held on 17 February 2025





GAC IG Group Discussions ahead of ICANN83

Examples of how GAC Members can inform, engage on and contribute to their national positions on the WSIS+20

- Establish **direct channels and close coordination with diplomats** at the UN in Geneva and New York
- **Close communication with and coordination among government departments** that lead the WSIS+20 Review, **sharing GAC Members technical expertise** and **highlight the benefits of/advocate for the multistakeholder model** and ICANN's role
- Provide **timely and early input to key governments stakeholders**, keep contributions concise and focused on important points
- **Integrate national and regional stakeholder communities** to ensure that their voices are reflected in the WSIS+20 Review (particularly technical community experts and civil society groups who could positively contribute to the discussion). Provide support for the workshops, identification of speakers, dissemination of information.
