- ICANN70 Meeting Introduction to UNESCO's Universality Indicators (Giacomo Mazzone)
- ICANN70 GAC Communique "Among the next steps relative to the WS2 recommendations implementation process, the HRILWG will be consulting with UNESCO to explore its "Universality Indicators for the Internet" issued in 2019 which measures how elements of diversity, disability, language, human rights, among others, are represented in the Internet environment in a given country."
- **Objective of the webinar** Continue discussions stemming from the ICANN70 session and exchange views on whether the Universality Indicators should be considered within the GAC WS2 (Work Stream 2) recommendations implementation process.
- **WS2**: November 2019, approval of 116 recommendations divided into the eight groups
- Our focus: Recommendations to improve Diversity and Recommendation for a Framework of Interpretation for Human Rights

Agenda Item 1. Rec. 1.1. Defining Diversity - The seven elements of diversity

- The core issues concerning the issue of diversity revolve around the need for a uniform definition of the parameters of diversity and a community discussion on the ones already identified:
 - Geographic or Regional Representation
 - Language
 - Gender
 - Age
 - Physical Disability
 - Diverse Skills
 - Stakeholder Group or Constituency
- This list may not be exhaustive. Each of the ICANN groups have some elements of diversity that are important to them based on their role within ICANN but not necessarily important to other groups across ICANN.
- Additional elements of diversity that are identified as important to GAC:
 Developed, developing and underserved region.

Agenda Item 1. Rec. 1.1. Def. Diversity - Comparison of two elements with the CRPD

WS2 Recommendation 1.1. The Elements of Diversity, Description of Issues:

- "Language: All languages should be possible to be represented in ICANN for the organization to position itself as a fully global multi-stakeholder entity. There is a need to improve the balance between the six official languages at ICANN: Arabic, Chinese, English, French, Russian and Spanish. However, ICANN manages the IANA functions that offers IDN services to some entities who do not use any of these six official languages, and it is very important that ICANN improve its ability to communicate with this group of stakeholders so that they can be better engaged."
- "Physical Disability: This element refers to the consideration of individuals across a range of different physical disabilities to participate in ICANN activities at various levels."

The Convention on the Rights of Persons with Disabilities (CRPD):

- "Language includes spoken and signed languages and other forms of non spoken languages."
- "Persons with disabilities include those who have long-term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others."
- The Convention does not explicitly define the word "disability"; indeed, the Preamble to the Convention acknowledges that "disability" is an evolving concept.

10 December 2009, UNESCO signed the agreement with ICANN

The UNESCO-ICANN cooperation agreement is intended to assist with the process of expanding the adoption of Internationalized Domain Names (IDNs).
