ICANN78 | AGM – GAC Opening Plenary Monday, October 23, 2023 – 1:15 to 2:30 HAM

GULTEN TEPE:

Hello and welcome to the ICANN 78 GAC opening plenary session being held on Monday 23rd of October at 11:15 UTC. My name is Gulten Tepe. I am the remote participation manager for this session. Please note that the session is being recorded and is governed by the ICANN expected standards of behavior. During this session, questions or comments submitted in the chat will only be read aloud if put in the proper form. I will read questions and comments aloud during the time set by the chair of this session. Interpretation for this session will include six UN languages and Portuguese. Click on the interpretation icon in Zoom and select the language you will listen to during this session. If you wish to speak, please raise your hand in the Zoom room, and once the session facilitator calls upon your name, kindly unmute your microphone and take the floor. NICOLAS CABALLERO:

Thank you very much, Gulten. Good afternoon and good morning and good evening for those online, for those participating online, ladies and gentlemen, distinguished GAC representatives. Welcome to ICANN 78 in Hamburg, Germany. It is an honor and a pleasure to be here with you today as we celebrate ICANN's 25th anniversary and the achievements and challenges of the DNS around the world.

Hamburg is Germany's second-largest city and Europe's largest commercial harbor, a city with a rich and diverse history, culture, and innovation. It's been home to many prestigious historical figures in many different fields. Let me mention just three of them. Frederick I Barbarossa, leader of the Holy Roman Empire in the 12th century. He gave Hamburg the title of free imperial city, and that way the tax-free access to the river Elbe, I hope I'm pronouncing the words well, to the lower river Elbe, enabled the city to become a key trading power in Europe. Klaus Stortebeker, the legendary pirate who defied the authorities and challenged the status quo in the 15th century. He is remembered as a hero and a rebel who fought for freedom and justice on the seas. In more modern times, Angela Merkel, the first female chancellor of Germany and one of the most influential leaders in Europe was born in Hamburg where her parents met and studied. Even though they were obviously not German, the Beatles, the iconic British band that revolutionized music, the Beatles themselves, they started their career in Hamburg, as far as I understand, where they played hundreds of concerts and developed their unique style and skills. These are just some examples of Hamburg's historical significance in my humble opinion.



Today Hamburg continues to be a hub of creativity, diversity and innovation, especially in the digital field. This year marks the 25th anniversary of ICANN, which began back in 1998, constituted by internet industry experts and enthusiasts who shared a common vision and passion for the DNS and digital technology. Since then ICANN has grown and evolved into a global platform that brings together governments, businesses, academia, civil society, registries and registrars to exchange ideas, experiences and best practices on how to harness the potential of the DNS industry for the benefit of all.

ICANN has also witnessed and reflected the tremendous progress that has been made in terms of DNS and digital technology in the past 25 years, as has already been mentioned many times during the opening speeches and the opening plenary and so on and so forth. From the emergence of the internet and social media platforms, the development of artificial intelligence and blockchain, to the advent of cloud and quantum computing and big data, technology has transformed every aspect of our lives and societies, however, it also poses significant challenges that require our collective attention and action. These include issues such as cyber security, data protection, DNS abuse, digital inclusion, digital rights, digital ethics and so on and so forth. These are some of the topics that we will address and discuss during ICANN 78 with the aim of finding solutions that are innovative, inclusive and responsible.

I would like to thank our local hosts and the German government in the person of Mr. Benjamin Bracke, Director General for Digital and Data Policy in the Federal Ministry for Digital and Transport, and Mr. Rudy Nolde, over there, representative, GAC representative for Germany, for

their generous support and hospitality. I would also like to thank very especially all the speakers, moderators, sponsors, partners, volunteers and staff who have made this conference possible and most importantly I would like to thank all of you distinguished GAC representatives who have joined us today both in person and online for your interest and participation. I hope you will enjoy this conference as much as I do and I look forward to learning from you and with you. I'm confident that together we can make a positive difference for the DNS and for our digital future. And now without further ado I would like to give the floor to Minister Bracke, please join me in welcoming him with a warm applause.

BENJAMIN BRACKE:

Thank you very much, thank you very much, dear Nico, dear GAC vice-chairs, distinguished members of the Governmental Advisory Committee, I'm really happy to welcome you all here in the most beautiful city in Germany, Hamburg. As has been mentioned before, this is only the second time an ICANN meeting is held in Germany. During ICANN 02 in Berlin, the GAC met for the second time. Germany has been a founding member of the GAC and was one of only 25 members and observers that were present during the GAC inaugural meeting in March of 1999. And while today 182 governments and 38 observer organizations are part of the GAC, the number was only 33 in total when the GAC met in Berlin in 1999. This shows that the GAC has stood the test of time and that it is indeed the legitimate representation of governmental stakeholders within the ICANN system.



Back in Berlin in 1999, the GAC established its first operating principles. They discussed pressing topics of that time such like the protection of intellectual property in the domain names, but also procedures for the management of country code top-level domains. I might also add, back in 1999, the GAC communique was only two pages long. Remember that. 24 years later, the digital world has changed quite significantly. The application layer of the internet has dominated the digital discourse in the past years. With the rise of social media platforms, blockchain, artificial intelligence, IoT, governments have been challenged with redefining their roles in digital policy without risking fragmentation. Infrastructure also remains a key aspect of our digital policies example when looking at the digital divide within and between countries and regions. It is quite obvious, in confusing terrain and with a view to a constantly changing world, we all need a compass. The internet is global and that is why digital policy must also be global. We need to avoid fragmentation and segmentation.

That is why the German government is developing a strategy for international digital policy under the auspices of my ministry, the German Ministry for Digital and Transport. Our vision in this strategy is to shape a rule-based digital order with partners that promotes democracy, prosperity and resilience to our digital societies. To this end, we define common action guiding principles including working with partners in a value-based manner, actively shaping international standards and norms, and strengthening a secure digital infrastructure.

Another very important principle in this strategy is we advocate a global, open, free and secure internet based on the multi-stakeholder model. This could not be mentioned often enough. This principle too is

deliberately strategic in nature. It is intended to serve as a long-term compass for our international digital policy. But concrete action is naturally derived from those principles. We see the multi-stakeholder approach as essential for global digital networking. Thus, we will continue to advocate for the central role of established institution in technical internet governance.

Impulses from both national and international stakeholders were incorporated at an early stage. We had two stakeholder forums in May 2023. The involvement of stakeholders has greatly helped us to understand and to take into account the priority and expectations of such a strategy. In addition to close coordination within the federal government, we intend to continue this exchange with stakeholders.

As I'm sure many of you are aware, the federal government was also represented at the Internet Governance Forum in Kyoto two weeks ago. There, State Secretary Stefan Schnorr renewed our commitment to the multi-stakeholder model. In the upcoming negotiations on the digital and the global digital compact and the WSIS+20 review, we will work to ensure that the involvement of all stakeholders remains a cornerstone of global digital cooperation.

ICANN has also proven its worth as a multi-stakeholder platform. This not least to the fact that ICANN plays a fundamental role in the technical administration of the internet. ICANN and its community can work day by day—No, not can, they actually do, ICANN and its community work day by day to ensure that our internet remains interoperable, stable and secure. The coordination of the internet's unique identifiers, especially IP addresses and the root zone of the domain name system

is a task that bears tremendous global responsibility. After 25 years, we can say ICANN has proven to be up to the job. And I say that being well aware that the solutions coming out of the ICANN policy development processes are not always satisfactory for everyone, including the GAC. But only the multi-stakeholder model guarantees that ever voice can and will be heard. I encourage everyone here to engage in the GAC to make sure your voice will be heard.

In closing, I wish you success in your work during the next days and as I have done so this morning, I invite you to our welcome reception hosted by our Parliamentary State Secretary Daniela Kluckert today at 5:30. Thank you very much and wishing you successful work.

NICOLAS CABALLERO:

Thank you so much Minister Bracke, I heard by the way we'll have the best beer in Germany for that reception if I'm not mistaken. So thank you so much. Before I give you a short review of our weekly agenda, let me also introduce my Vice-Chairs, Zeina Bou Harb from Lebanon and Nigel Hickson from the United Kingdom. Wang Lang from China as well. I think the only one missing unless he's sitting around here is Mr. Ola Bergström from Sweden. Is he around? And I don't see him.

So let me just give you a short review of the meeting for today. So first we will review the weekly agenda, then we'll have another review of meeting logistics by ICANN support staff. Then we'll have a Tour de Table for in-person and remote GAC participants. Then we'll have a short briefing on notable GAC activities since ICANN 77 in Washington, D.C. Then we'll touch a little bit upon the GAC communique development for ICANN 78. I'm sure you all received the emails



regarding the communique drafting. And then finally we'll give you the results of the 2023 GAC Vice-Chairs' election. So with that, can you move on to the next page, Gulten, please? Let's review the weekly agenda.

So I'll go basically day by day and then at the end of each day I'll pause for a while in order to see if there are any questions or anything you would like to clarify. So let's begin with Monday, which is today. As you can see, we have this session going up until 2:30. Then we'll have a short break until 3:00 PM. And then we'll have a meeting with the GNSO running for 60 minutes. Then another break at 4:00 until 4:30. Then we'll have the geopolitical updates and that session will also be running for 60 minutes. Right after that we'll have the welcome reception by the German government with the best beer in the country, according to Minister Bracke. So do we have any questions, anything so far?

If not, let me move on to Tuesday, October 24th. This is the only day, and apologies beforehand, this is the only day in which we will start at 8:30 in the morning. So we'll have the discussion on the new gTLD program, the first session basically, out of two. That session will be running for 60 minutes. Then we'll have a short break from 8:30 to 10:00. Right after that, the number you see there is actually the number of the sessions according to the GAC schedule. It doesn't necessarily coincide with the rest of the sessions, just in case. On GAC operational matters, NomCom, planning, working groups, and so on and so forth. That session will be running for 60 minutes. Then we'll have another short break. Right after that, we'll have the GAC and ALAC meeting. That session will also be running for 60 minutes. And then we'll have, unfortunately, a little bit shorter lunch break, until 1:00 PM. Right after that, we'll have the ICANN board and GAC meeting. Again, that session



running for 60 minutes. Short break at 2:30 till 3:00 PM. Right after the break, we'll have another session on the GAC discussing WHOIS data protection policy, including accuracy. That session will run for 60 minutes. The break at 4:00 PM till 4.00. And finally, we get to the first communique drafting session, running for 60 minutes again. So I'll pause here and see if there are any questions. Any comments?

If that is not the case, let's talk about Wednesday, October 25th. We start at 9:00 AM, as you can see there, with GAC discussions on new gTLD program next round. The second session, basically, running for 60 minutes. Then a short break from 10:00 to 10:30. Right after that, we will have the GAC discussion on DNS abuse. That session will be running for 90 minutes, as you can see there. Then a longer lunch break, a 90-minute break for lunch. And right after that, we'll continue with the communique drafting. As you can see there, that session will run for two hours, that is 120 minutes. We'll have a short break at 3:30 PM. And then right after that, at 4:00 PM, we'll have the final, not the final, the final for the day, right, GAC communique drafting session, running for 90 minutes. And then we have the ICANN 25th anniversary reception. I'm not sure about the beer arrangements for that session, but I can find out and let you know later on. Any questions? Any questions so far, up until this point?

Seeing none, let me continue with the sessions on Thursday, October 25th. We'll continue with the GAC communique drafting session, running for 60 minutes. Then at 10:00 AM, a short break. 10:30 AM, running in parallel with the ICANN public forum, we'll have another communique drafting if needed. Hopefully not, but you never know. The devil is in the details, as the old saying goes, so we might need to

fine tune and adjust whatever wording at that point. Then we'll have the lunch break and at 1:15 PM, depending on the situation, we'll have the GAC wrap up or another final round of fine tune for the GAC communique. As you can see there, then we'll have a break. Then there's an approval action community forum running for 30 minutes. This basically has to do with the ECA, empowered community administration. Then another break at 3:30 and then at 4:00 PM, finally, we have the 25th annual general meeting and including the public meeting of ICANN board, that session running for another 90 minutes and I also have to be there as the GAC liaison with the board. I'll pause here and see if there are any questions. Is everything all right?

Seeing no questions, now we'll have a short review of meeting logistics. For that, let me turn this over to GAC staff. Gulten, the floor is yours. Please go ahead.

UNIDENTIFIED SPEAKER:2

Thank you, Nico. Hello again, everyone. I'll provide a brief overview of the meeting logistics, as Nico mentioned, and some details about the technical capabilities. Initially, about the calendar invitations, if you recall, I already shared invites for each GAC session last week. You may want to check those invites as you would find the links to GAC website and ICANN meetings page for each respective session. If you are not able to attend the session due to time zone difference or because of other commitments, you may want to listen to recordings or review the slides. I will be sharing a link to the page in the chat for your convenience where we would publish the materials being presented.



Just like previous meetings for ICANN 78, we didn't share any Zoom room link on the calendar invitations, as this was advised by our E&IT team. I will be updating the invites once remote connection details are available. This would be before 24 hours each session.

Regarding the session page on the GAC website, the first note would be to always remember to be logged in, otherwise you will not be able to see the documents, since some of them are visible only to GAC members, and they will be released publicly after these sessions take place. We already published the briefings in English, and their translations will also be available. After the sessions, I will be adding links to recordings and transcripts on the GAC website for each session as well.

Under the introduction part on the ICANN 78 agenda page, you may find other valuable resources and materials. I will be sharing the link in the chat to that page very shortly. During the sessions, please remember to sign into Zoom platform using your full name. There is also a rename option available on the Zoom participants section. You are able to add your affiliation, country, or organization you are representing nearby your name. It is possible to do that by hovering over your name on the attendee list. More options will appear, and you can click on Rename. It will allow you to update your name and enter GAC into parentheses. This will help us to keep accurate attendance. You can also help our interpreters by following simple guidelines. If you intend to speak in a language other than English, please notify the audience. This will be a good heads-up for our interpreters. There will be a brief switch over time when switching between interpretation from a language to the other one. Please remember to state your name every time you take the



floor, and don't speak too close to the microphone or too far away. Remember to mute all other devices, your phone, iPads, and so on. Please turn off your notifications. A couple of notes for our in-person attendees who are here in Hamburg, Germany with us. We have reserved GAC delegation seats at the tables with microphones. Other committee members are welcome to join our sessions, but we would much appreciate if they can take the seats on the back of the room, leaving the seats on the tables to GAC committee members. Also seats will be reserved in front rows for some sessions, including the joint meetings with ICANN Board and GNSO, as well as ALAC.

Additionally, I would like to display a couple of visuals on the screen regarding Zoom functions and remind in-person attendees only to use microphones on the tables. If you try to use your laptop to speak, it would create an echo in the room. And a slide that shows how remote participants can join the audio. If you have any questions, I would be happy to answer. Please share that in the chat pod or you can always

send us an email by gac-staff@icann.org. That concludes my part, Nico. Thank you.

NICOLAS CABALLERO:

Thank you very much, Gulten. So now we'll go ahead with the tour de table. Basically what we need to do here is state our names and the institution and the country we represent. Of course, unless you have a statement or something you would like to share with the whole GAC. But for the sake of time, I just beg you to keep it short and sweet. We will begin with the distinguished colleagues who are in the room and then with the online representatives. We will start over here. Please go ahead.

CELLOU DIALLO:

Good afternoon, everyone. I represent the Republic of Guinea. I have the pleasure to give the floor to the ICT minister of the Republic of Guinea, [inaudible]. He wishes to take the floor. We thank the GAC's leadership for giving this opportunity to the minister.

UNIDENTIFIED SPEAKER:

Thank you very much, dear participants. I would like to thank the German government for providing us this opportunity to speak to this audience and welcome us in this GAC session. The Republic of Guinea has made the digital transformation a cornerstone of its action because it fosters development and gives the population essential public services at a lesser cost and with more effectiveness. I would like to illustrate this. The Republic of Guinea is around 200,000 square kilometers. If a national wants to get a passport, he must drive 1,200



kilometers to go to the capital in order to get a passport, and it's the same for many official documents. We wanted to give the opportunity to our citizens to collect these official documents digitally. This approach is based on a multi-stakeholder approach. We also want to develop the Internet in our countries thanks to this approach, and to this end, we need to collaborate with the government, with civil society, and with the private sector, as well as the Internet community at large. This digital transformation must also be supported by the way we manage the DNS, and repatriating the TLD .NG took more than 20 years for us. We want for this domain name to be a testament to the sovereignty of our country. It was a tall order, but we were able to wrap this up recently thanks to many stakeholders, and we are now able to provide this domain name for many an organization, commercial or public. And I know we're getting help from the U.S., but also from [inaudible] one of our nationals, and they were able to help us to that end. We were able to overcome a number of issues, and these issues were really troublesome for the development of our digital network. So having this domain name is as important as having our flag flying at the United Nations. It's as important as the Guinea phone number. It was important for the development of the digital sector in our country, which is currently benefiting from tailwinds. So we are proud that we have been able to repatriate the .NG, and this happened thanks to the collaboration of a number of actors, including international organizations. We were able to move forward with this. We benefited from technical and administrative support from a South African company. This South African company has been helping us since 2019, and we were able to benefit from the delegation of the ccTLD. In October 2022, we were able to acquire and deploy the infrastructure



necessary to host this technology. We also have a local data center. We have our own company managing the underwater cable network, and we were able to manage the registry locally. We were able to train engineers, and we benefited from the invaluable support of the ECH that is operating in Guinea since July 2023. This collaboration was also possible thanks to the help of [Randy Bush] in Texas, and this is a major milestone in Guinea's history. ICANN, which provided a lot of technical support for these efforts. So this is not a unique experience in Africa. There are many countries that are at pains with having their own domain name, their own ccTLD. And sometimes it is really discouraging. Many people and many companies in a number of countries are discouraged by this, and I believe it is high time that the ICANN thinks about another approach, an approach that helps countries and organizations that are involved in the digital sphere to facilitate this action. It took us 30 years before we had our ccTLD, 30 years before we had our own digital identity, an identity which is instrumental to maintaining Guinea's presence in the digital world. So this is really a milestone for our country. It is a crucial step towards digital sovereignty, towards our online independence, and this will foster further digital development and will ensure the availability of public services for the population. Thank you very much. Thanks for everything you did to help us overcome this challenge. And in the name of digital companies in the Republic of Guinea, in the name of my ministry, of the country's authorities, I want to thank you for this essential contribution. Our vision for a digital Guinea has been made possible with your help, because we were able to create a local ecosystem, managed locally, and this way we were able to do our part in this global digital society.



NICOLAS CABALLERO: Thank you very much. Thanks to the Minister, thanks to the Republic of

Guinea.

Thank you.

UNIDENTIFIED SPEAKER:2 Thank you very much. And that was all from our remote participants.

NICOLAS CABALLERO: Thank you very much, Gulten. Thank you, everyone. And now, again, for

the sake of time, let me give the floor directly to Rob Hoggarth for some

important updates and housekeeping details. Rob, please go ahead.

ROBERT HOGGARTH: I'm sorry, Mr. Chair, that we weren't able to review the

accomplishments since ICANN 77. And many of you who are familiar

with the communique process, you can re-familiarize yourselves with

what's on the slides. And we're happy to chat with others about that

process.

NICOLAS CABALLERO: Just one second. Before I forget, let me give the floor to the UK, to

Lebanon. They didn't have the chance to introduce themselves. I'm very

sorry about that. Nigel, the floor is yours.

NIGEL HICKSON. Oh, yes. Thank you very much. Nigel Hickson, assigned from the

Department of Science, Innovation and Technology in the UK. Delightful to be here. Wonderful place. And also looking forward to the

dark beer rather than the light beer.

ZEINA BOU HARB: Good afternoon, everyone. This is Zeine Bou Harb from OGERO

Telecom, the incumbent public operator in Lebanon. And I represent the Lebanese government as alternate GAC member. And if I may, please, I would like to welcome the new GAC members and ask them,

please do not hesitate to approach any of the other GACs if you have any question or any issues that you would like to inquire about. Please.

WANG LANG: Good afternoon, good evening. I'm Wang Lang from China. Glad to meet

you here in person. Hope you have a fruitful conference these days. Let

me thank Germany for hosting this fantastic event. Thank you.

NICOLAS CABALLERO: Thank you very much. My apologies again. Rob, back to you.

ROBERT HOGGARTH: I like your theatrics in terms of postponing the election announcement

until the very end of the session. Thank you. So as I was noting before,

the communique is the critical element of your work product for the course of the week. Nico has shared opportunities to provide language

for the communique and topics already. So we hope that many of you

will take advantage of that opportunity. You've got about eight hours of

conversation scheduled later in the week and hope that those will be fruitful for you. Now, just turning to the vice chair's election, it's an election that takes place on an annual basis for the vice chairs who serve one-year terms. Nico serves a two-year term, so he was not subject to any election period. He actually, in that capacity, then acted as our observer for the election process. So thanks very much, Nico, for that oversight this time around.

We had a great slate of candidates for this year's election. In past years, there was not as much interest in volunteering and serving. I think it's a reflection of all of you and your interest and recognition of the value of the committee and the work that you do that many more of you are expressing an interest in serving. And I think the present vice chairs, as well as Nico, can note that that truly is a service that you all offer when you appreciate the amount of work that the leadership, the chair and vice chairs devote to the work that you all do. And it's very much appreciated, certainly by the staff and I know by the members of the committee.

So we had eight candidates for this year's election, from which only five could be selected. We had 119 ballots, and the purpose of this presentation is to confirm for you that there was the appropriate more than one-third quorum. In fact, we had close to two-thirds of you voting in this election. So thank you not only to those who stepped forward to offer your services to the committee, but to those of you who took the time, made the effort and made some difficult choices in your votes. So thanks very much for that. So I won't delay things any further. We're at the end of the session. So I'm pleased to announce that our present vice chairs, Nigel, Zeina and Wang Lang, were re-elected to their seats. And



you can go to the next slide, Gulten. And they'll be joined in the new year by Christine Arida from Egypt, as well as Thiago Dal-Toe from Colombia.

Now, Nico, just to clarify for everybody, it's a rather unusual process for the committee in that the election results are announced today, but the individuals don't begin their formal terms until the end of the next meeting. So next March, they'll serve for three additional meetings. However, the tradition of the chair, vice chair group is to invite those individuals to participate in activities, meetings and calls starting after this meeting. So we'll welcome those additional individuals to join the leadership group. That's really all I have to share today. Nico, thanks very much. I'll turn it back to you.

NICOLAS CABALLERO:

Thank you so much, Rob. So again, congratulations to the newly elected vice chairs. They will be invited to attend upcoming leadership calls after the Hamburg meeting, certainly for the Puerto Rico, for the San Juan session. So thank you again to all the candidates. We really appreciate your stepping forward for the position. The meeting is adjourned. Thank you so much.
